**TUITION INCLUDES:**

Board and Lodging, Infirmary, Instruction, Guidance, Training and Complete Ranch Privileges under careful supervision; Trips to points of interest, except 3- and 4-day raft trips. Should a camper arrive without a health form, a doctor chosen by the camp will perform the examination at the parents' expense. **The Fee includes all expenses except personal expenses, health and accident insurance, spending allowances and transportation from the camper's home to Anderson Camps, and the 3- and 4-day trips mentioned below.**

**EXTRA COST TRIPS:**

Because of unusually high expenses connected with the raft trips, it is necessary for us to make additional charges for them. Please indicate below your permission for your Colorado River Ranch or Hill Top Ranch camper to choose these trips if he or she desires. No extra charges are made for other trips, such as horseback, mountain climbing, touring, and caving trips, which are offered at the same time as the rafting trips.

**The Ranch Fee terms of payment are as follows: \$700.00 (U.S. Dollars) sent with the Application for Enrollment; the balance due ten days before the first day of the enrolled term.**

**OTHER ARRANGEMENTS AND SPECIAL CONDITIONS:**

1. Ranch expenses are fixed in advance, based upon a definite number of campers for specified times, hence **no rebates or deductions from the fee can be made for entering late or leaving early.**
2. The Ranch will provide every reasonable safeguard for the health and welfare of each camper, but will not be responsible for accidents, sickness, or lost articles.
3. The release of campers to persons other than the legal parents or guardian shall not be allowed without the written consent of the latter.
4. In cases of illness or injury, parents will be notified as soon as possible. Their wishes will be carried out as fully as practicable. All expenses incurred will be borne by the parents.

**PARENT'S AUTHORIZATION**

The person herein described has permission to engage in all prescribed camp activities as noted by me and the examining physician on the health history. In the event I cannot be reached in an EMERGENCY, I hereby give permission to the camp to transport and to the physician selected by the camp director to hospitalize, secure proper treatment for, and to order injection, anesthesia or surgery for my child as named in this application. 5. In the event of absence from the Ranch due to illness for a period of more than two weeks, financial loss of camp fee will be shared equally between the ranch management and the parents.

7. In signing the application the parent or guardian consents to their child participating in all out-of-camp trips whether on foot or by vehicle.
8. In signing the application, parents or guardians understand they cannot telephone their child at camp unless there is an emergency.

**RESERVATIONS**

Reservations cannot be made until the application form has been completed and an advance payment of \$700.00 (U.S. Dollars) has been received. It is understood that the Director reserves the right to refuse admission or to sever connection, of any camper whose influence is deemed harmful to the best interest of the Ranch and its morale.

**CANCELLATIONS**

The camp will refund \$200.00 of the initial enrollment fee for change of plans if notice is given to the Director of the Camp by April 1, 2012. No refund will be made after April 1, 2012. **No exceptions.**

In signing the application the parent certifies that the camper is in good, normal health, has no abnormal tendencies, and would make a desirable companion for other children. Final detailed pre-camp instructions will be mailed to all campers and their parents in April.
